**ISSUE OF DUKETON MINING LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

On 18 October 2017, Duketon Mining Limited ("**Company**") issued 148,148 fully paid ordinary shares at a deemed issued price of \$0.135 per share ("**Securities**").
